# NOTES TO THE UNAUDITED CONDENSED CONSOLIDATED FINANCIAL STATEMENTS

For the nine months ended 31 December 2019

#### 1. General information

The Company is incorporated in the Cayman Islands with limited liability under the Companies Law (as revised) of the Cayman Islands. The address of the Company's registered office is PO Box 1350, Clifton House, 75 Fort Street, Grand Cayman, KY1-1108, Cayman Islands.

The Company is an investment holding company. The Group is principally engaged in design, marketing, distribution and retail sales of toys and related products.

The measurement basis used in the preparation of the unaudited condensed consolidated financial statements is the historical cost basis except that the investment property is stated at fair value. The unaudited condensed consolidated financial statements are presented in Hong Kong dollars ("HK\$") and all figures are rounded to the nearest thousand ("HK\$"000") unless otherwise indicated.

#### 1. 一般資料

本公司根據開曼群島公司法(經修訂) 於開曼群島註冊成立為有限公司。本 公司的註冊辦事處地址位於PO Box 1350, Clifton House, 75 Fort Street, Grand Cayman, KY1-1108, Cayman Islands。

本公司為投資控股公司。本集團主要從 事設計、市場推廣、分銷及零售銷售玩 具及相關產品。

編製未經審核簡明綜合財務報表使用的計量基準為歷史成本基準,惟投資物業按公平值列賬。未經審核簡明綜合財務報表乃以港元(「港元」)呈列,除另有指明外,所有數字均四捨五入至最接近的千位(「千港元」)。

# 2. Basis of preparation

This third quarterly financial report has been prepared in accordance with all applicable Hong Kong Financial Reporting Standards ("HKFRSs"), which collective term includes all applicable individual HKFRS, Hong Kong Accounting Standards ("HKASs") and Interpretations issued by the Hong Kong Institute of Certified Public Accountants ("HKICPA"), accounting principles generally accepted in Hong Kong and the applicable disclosure provisions of the GEM Listing Rules. It was authorised for issue on 11 February 2020.

The third quarterly financial report has been prepared in accordance with the same accounting policies adopted in the 2019 annual financial statements, except for the accounting policy changes that are expected to be reflected in the 2020 annual financial statements. Details of any changes in accounting policies are set out in note 3.

This third quarterly financial report contains condensed consolidated financial statements and selected explanatory notes. The notes include an explanation of events and transactions that are significant to an understanding of the changes in financial position and performance of the Group since the 2019 annual financial consolidated statements. The third quarterly financial report and notes thereon do not include all of the information required for a full set of financial statements prepared in accordance with Hong Kong Financial Reporting Standards ("HKFRSs").

The third quarterly financial report has not been audited nor reviewed by the independent auditor but has been reviewed by the Audit Committee.

#### 2. 編製基準

本第三季度財務報告乃根據所有適用之香港財務報告準則(「香港財務報告準則」)(該統稱包括香港會計師公會(「香港財務報告準則」)(該統稱包括香港會計師公會(」)頒佈之所有適用個別香港財務報告準則、香港會計準則(「香港會計準則」)及詮釋)、香港公認會計原則及GEM上市規則之適用披露規定編製。其已於二零二零年二月十一日獲授權刊發。

第三季度財務報告已按照於二零一九年 年度財務報表所採納的相同會計政策編 製,惟預期將於二零二零年年度財務報 表內反映的會計政策變動則除外。任何 會計政策變動的詳情載於附註3。

本第三季度財務報告載有簡明綜合財務報表及選定説明附註。有關附註載列對了解本集團自刊發二零一九年年度財務綜合報表以來的財務狀況及表現的變化有重要影響的事件及交易的説明。第三季度財務報告及其附註並不包括按照香港財務報告準則(「香港財務報告準則」)就編製整份財務報表所需的全部資料。

第三季度財務報告未經獨立核數師審核 或審閱,但已由審核委員會審閱。

# 3. Changes in accounting policies

The HKICPA has issued a new HKFRS, HKFRS 16, Leases, and a number of amendments to HKFRSs that are first effective for the current accounting period of the Group.

Except for HKFRS 16, Leases, none of the developments have had a material effect on how the Group's results and financial position for the current or prior periods have been prepared or presented in this third quarterly financial report. The Group has not applied any new standard or interpretation that is not yet effective for the current accounting period.

#### HKFRS 16, Leases

HKFRS 16 replaces HKAS 17, Leases, and the related interpretations, HK(IFRIC) 4, Determining whether an arrangement contains a lease, HK(SIC) 15, Operating leases – incentives, and HK(SIC) 27, Evaluating the substance of transactions involving the legal form of a lease. It introduces a single accounting model for lessees, which requires a lessee to recognise a right-of-use asset and a lease liability for all leases, except for leases that have a lease term of 12 months or less ("short-term leases") and leases of low value assets. The lessor accounting requirements are brought forward from HKAS 17 substantially unchanged.

The Group has initially applied HKFRS 16 as from 1 April 2019. The Group has elected to use the modified retrospective approach and has therefore recognised the cumulative effect of initial application as an adjustment to the opening balance of equity at 1 April 2019. Comparative information has not been restated and continues to be reported under HKAS 17.

# 3. 會計政策的變動

香港會計師公會已頒佈於本集團今個會計期間首次生效之新訂香港財務報告準則、香港財務報告準則第16號「租賃」,以及多項香港財務報告準則的修訂。

除香港財務報告準則第16號「租賃」外,該等修訂對如何編製或呈列本集團於本第三季度財務報告當前或過往期間的業績及財務狀況概無重大影響。本集團並無採用任何當前會計期間尚未生效的新準則或詮釋。

#### 香港財務報告準則第16號「租賃 |

本集團自二零一九年四月一日起初步應用香港財務報告準則第16號。本集團已選擇採用經修訂的追溯法,因此已將初步應用的累計影響確認為二零一九年四月一日權益的期初結餘調整。本集團並未重列比較資料,並繼續根據香港會計準則第17號呈報。

Further details of the nature and effect of the changes to previous accounting policies and the transition options applied are set out below:

## (a) Changes in the accounting policies

#### (i) New definition of a lease

The change in the definition of a lease mainly relates to the concept of control. HKFRS 16 defines a lease on the basis of whether a customer controls the use of an identified asset for a period of time, which may be determined by a defined amount of use. Control is conveyed where the customer has both the right to direct the use of the identified asset and to obtain substantially all of the economic benefits from that use.

The Group applies the new definition of a lease in HKFRS 16 only to contracts that were entered into or changed on or after 1 April 2019. For contracts entered into before 1 April 2019, the Group has used the transitional practical expedient to grandfather the previous assessment of which existing arrangements are or contain leases.

Accordingly, contracts that were previously assessed as leases under HKAS 17 continue to be accounted for as leases under HKFRS 16 and contracts previously assessed as non-lease service arrangements continue to be accounted for as executory contracts.

有關過往會計政策變動的性質及影響以 及所採用的過渡性選擇的進一步詳情載 列如下:

## (a) 會計政策變動

# (i) 租賃的新定義

租賃定義的變動主要與控制權的概念有關。香港財務報告準則第16號根據客戶是否在某一時段內控制已識別資產的使用(其可由指定使用量釐定)而對租賃作出定義。當客戶人有權該示可識別資產的用途以及濟利益中獲得絕大部分經濟利益時,即表示擁有控制權。

香港財務報告準則第16號內租賃的新定義僅適用於本集運適用於本集運適用於本集運的一九年四月一日或之。 訂立或變更的合約。就於二零一九年四月一日之前訂立的合約而言,本集團已採用過屬租價可行的權宜方法以豁免屬租賃的現有安排的過往評估。

因此,先前根據香港會計準則 第17號評估為租賃的合約繼續 根據香港財務報告準則第16號 入賬列為租賃,而先前評估為 非租賃服務安排的合約則繼續 入賬列為未履行合約。

## (ii) Lessee accounting

HKFRS 16 eliminates the requirement for a lessee to classify leases as either operating leases or finance leases, as was previously required by HKAS 17. Instead, the Group is required to capitalise all leases when it is the lessee, including leases previously classified as operating leases under HKAS 17, other than those short-term leases and leases of low-value assets. As far as the Group is concerned, these newly capitalised leases are primarily in relation to property, plant and equipment as disclosed in note 11.

When the Group enters into a lease in respect of a low-value asset, the Group decides whether to capitalise the lease on a lease-by-lease basis. For the Group, low-value assets are typically laptops or office equipments. The lease payments associated with those leases which are not capitalised are recognised as an expense on a systematic basis over the lease term.

Where the lease is capitalised, the lease liability is initially recognised at the present value of the lease payments payable over the lease term, discounted using the interest rate implicit in the lease or, if that rate cannot be readily determined, using a relevant incremental borrowing rate. After initial recognition, the lease liability is measured at amortised cost and interest expense is calculated using the effective interest method. Variable lease payments that do not depend on an index or rate are not included in the measurement of the lease liability and hence are charged to profit or loss in the accounting period in which they are incurred.

The right-of-use asset recognised when a lease is capitalised is initially measured at cost, which comprises the initial amount of the lease liability plus any lease payments made at or before the commencement date, and any initial direct costs incurred. Where applicable, the cost of the right-of-use assets also includes an estimate of costs to dismantle and remove the underlying asset or to restore the underlying asset or the site on which it is located, discounted to their present value, less any lease incentives received.

The right-of-use asset is subsequently stated at cost less accumulated depreciation and impairment losses, except for the right-of-use assets that meet the definition of investment property are carried at fair value.

The lease liability is remeasured when there is a change in future lease payments arising from a change in an index or rate, or there is a change in the Group's estimate of the amount expected to be payable under a residual value guarantee, or there is a change arising from the reassessment of whether the Group will be reasonably certain to exercise a purchase, extension or termination option. When the lease liability is remeasured in this way, a corresponding adjustment is made to the carrying amount of the rightof-use asset, or is recorded in profit or loss if the carrying amount of the right-ofuse asset has been reduced to zero.

## (iii) Leasehold investment property

Under HKFRS 16, the Group is required to account for all leasehold properties as investment properties when these properties are held to earn rental income and/or for capital appreciation ("leasehold investment properties"). The adoption of HKFRS 16 does not have a significant impact on the Group's financial statements as the Group previously elected to apply HKAS 40, *Investment properties*, to account for all of its leasehold properties that were held for investment purposes as at 31 March 2019. Consequentially, these leasehold investment properties continue to be carried at fair value.

# (iv) Lessor accounting

The Group leases out the investment property referred to in paragraph (a)(iii) above as the lessor of operating leases. The accounting policies applicable to the Group as a lessor remain substantially unchanged from those under HKAS 17.

Under HKFRS 16, when the Group acts as an intermediate lessor in a sublease arrangement, the Group is required to classify the sublease as a finance lease or an operating lease by reference to the right-of-use asset arising from the head lease, instead of by reference to the underlying asset. The adoption of HKFRS 16 does not have a significant impact on the Group's financial statements in this recard.

The Group's customers are primarily distributors based in Japan. The percentage of revenue contributed by the Group's five largest customers for the Period amounted to approximately 77% (the Corresponding Period: 73%). Further details regarding the Group's principal activities are disclosed below.

The Group manages its business by three divisions, namely sale of ODM toys, sale of own licensed toys and distribution of imported toys. In a manner consistent with the way in which information is reported internally to the Group's most senior executive management for the purposes of resource allocation and performance assessment, the Group has identified the above three reportable segments. No operating segments have been aggregated to form the above reportable segments.

As discussed in note 3, the Group has initially applied HKFRS 16 using the modified retrospective method and adjusted the opening balances at 1 April 2019 to recognise right-of-use assets relating to leases which were previously classified as operating leases under HKAS 17. Further details on the net book value of the Group's right-of-use assets by class of underlying asset are set out in note 3.

During the Period, the Group entered into a number of lease agreements for use of retail stores, and therefore recognised the additions to right-of-use assets of HK\$7,489,000. The leases of retail stores contain variable lease payment terms that are based on sales generated from the retail stores and minimum annual lease payment terms that are fixed. These payment terms are common in retail stores in Hong Kong where the Group operates.

## (b) Acquisitions and disposals of owned assets

During the Period, the Group acquired items of plant and machinery with a cost of HK\$6,623,000 (the Corresponding Period: HK\$2,285,000).

Investment property with carrying amount of HK\$10,300,000 was disposed of during the Period (the Corresponding Period: Nil), resulting in a gain on disposal of HK\$500,000 (the Corresponding Period: Nil).

# MANAGEMENT DISCUSSION AND ANALYSIS

## **Business review and outlook**

The Group is principally engaged in design, marketing, distribution and retail sales of toys and related products.

### **Business review**

For the Period as compared to the Corresponding Period, the Group's revenue increased by approximately 16.5% while gross profit decreased by approximately 7.0%.

# Business in the sales of ODM toys to license holder

The Group's revenue in the sales of ODM toys to license holders increased by approximately 46.9% to approximately HK\$109,695,000 (the Corresponding Period: approximately HK\$74,653,000).

The increase in revenue from this segment was primarily because the number of product item and sold quantity were highly raised in the Period.

#### Business in the distribution of imported toys

The Group's revenue in the distribution of imported toys substantially decreased by approximately 32.6% to approximately HK\$30,547,000 (the Corresponding Period: approximately HK\$45,339,000).

The decrease in revenue from the distribution of imported toys was mainly because two new highend robot figures were released and delivered in the Corresponding Period.

# Business in the sales of own licensed toys

The Group's revenue in the sales of own licensed toys increased by approximately 14.1% to approximately HK\$22,074,000 (the Corresponding Period: approximately HK\$19,345,000).

The increase in revenue from the sales of own licensed toys was primarily because couple of high end figure models were newly released in the Period, which constantly provide stable revenue to the Group.

來自本分部之收益增加乃主要由於產品項目數目及出售數量於本期間大幅增加。

#### 分銷進口玩具業務

本集團分銷進口玩具之收益大幅下降約32.6%至約30,547,000港元(去年同期:約45,339,000港元)。

分銷進口玩具之收益減少乃主要由於去年 同期發佈及交付兩個新款高端機械人模型 所致。

#### 銷售自家特許玩具業務

本集團銷售自家特許玩具之收益增加約14.1%至約22,074,000港元(去年同期:約19,345,000港元)。

銷售自家特許玩具之收益增加乃主要由於 多款高端手辦模型於本期間最新發佈並為 本集團提供持續穩定收益。

# Financial analysis

#### Revenue

Revenue increased by approximately 16.5% to approximately HK\$162,316,000 for the Period from approximately HK\$139,337,000 for the Corresponding Period. The increase in revenue was mainly due to the increase in revenue from (i) sales of own licensed toys; and (ii) sales of the ODM toys in the Period.

#### Cost of sales

Cost of sales increased by approximately 24.6% to approximately HK\$128,958,000 for the Period from approximately HK\$103,486,000 for the Corresponding Period. The increase of cost of sales is align with the increase of revenue

## **Gross profit**

Gross profit decreased by approximately 7.0% to approximately HK\$33,358,000 for the Period from approximately HK\$35,851,000 for the Corresponding Period. The gross profit margin decreased to 20.6% for the Period from approximately 25.7% for the Corresponding Period due to the increase in sales proportion of sale of ODM toys which has lower gross margin in current period in the three reportable segments.

# Other net income

Other income increased by approximately 135.7% to approximately HK\$4,599,000 for the Period from approximately HK\$1,951,000 for the Corresponding Period.

The increase was mainly due to (i) gain on disposal of investment property; (ii) sundry income; and (iii) management fee income.

### Selling expenses

Selling expenses increased by approximately 67.1% to approximately HK\$7,078,000 for the Period from approximately HK\$4,237,000 for the Corresponding Period, mainly due to (i) the increase of selling staff; (ii) the increase of postage and delivery fee; (iii) rental expense for the newly opened retail restores; and (iv) the increase of advertising and promotion expense.

#### 財務分析

其他收入由去年同期約1,951,000港元增加約135.7%至本期間約4,599,000港元。

此項增加主要由於(i)出售投資物業的收益; (ii)雜項收益;及(iii)管理費收入所致。

#### Administrative expenses

Administrative expenses increased by approximately 47.1% to approximately HK\$19,433,000 for the Period from approximately HK\$13,209,000 for the Corresponding Period. The increased expense was mainly presented by (i) increasing in staff costs due to increase in salary and number of staff; and (ii) additional expense for the office in Mainland China.

#### Event after the reporting period

There is no significant event subsequent to 31 December 2019 which would materially affect the Group's operating and financial performance.

# Liquidity, financial resources and funding

As at 31 December 2019, we had cash and bank deposits of approximately HK\$107,731,000 (31 March 2019: approximately HK\$110,970,000), which were cash at banks and on hand and bank deposits.

As at 31 December 2019, no bank deposit was pledged (31 March 2019: nil).

As at 31 December 2019, the Group's indebtedness comprised bank loans of HK\$3,670,000 (31 March 2019: HK\$6,374,000) and lease liabilities of HK\$6,831,000 (31 March 2019: nil).

The Group's gearing ratio, which is calculated by total debt (defined as bank and other debts incurred not in the ordinary course of business) divided by total equity, was 0.06 times as at 31 December 2019 (31 March 2019: 0.04 times).

#### **Capital structure**

As at 31 December 2019 and 31 March 2019, the capital structure of our Company comprised issued share capital and reserves.

# Future plans for material investments and capital assets

Save as disclosed in the prospectus of the Company dated 18 May 2018 (the "Prospectus"), the Group did not have other plans for material investments and capital assets.

Foreign currency risk refers to the risk that the fair value or future cash flows of a financial instrument will fluctuate because of changes in foreign exchange rates. The Group mainly operates in Hong Kong with most of the transactions denominated and settled in HK\$.

During the Period, the Group's exposure to foreign currency risk primarily arose from certain financial instruments including trade and other receivables, cash and cash equivalents and trade and other payables which are denominated in JPY, RMB and/or US\$. During the Period and the Corresponding Period, the Group did not adopt any hedging strategy but the management continuously monitored the foreign exchange risk exposure on a case-by-case basis. The Group did not use any hedging contracts to engage in speculative activities during the Period and the Corresponding Period.

# Charge on group's assets

At 31 December 2019, the Group's leasehold land and building with an aggregate carrying value of HK\$6,466,000 were mortgaged to secure banking facilities granted to the Group (31 March 2019: HK\$16,899,000).

## Information on employees

As at 31 December 2019, the Group had 42 employees (31 March 2019: 44) working in Hong Kong. Employees are remunerated according to their performance and work experience. On top of basic salary, commission, discretionary bonus and share option may be granted to eligible staff by reference to the Group's performance as well as individual's performance. The remuneration of the Directors for the Period amounted to approximately HK\$2,228,000 (the Corresponding Period: approximately HK\$2,484,000).

## Use of proceeds

The ordinary share(s) of our Company (the "Shares") were listed on GEM on 31 May 2018. The net proceeds from the Listing of our Shares on GEM (the "Listing") (after deducting the underwriting fees and related expenses) amounted to approximately HK\$58 million. Up to 31 December 2019, the actual use of proceeds and an unutilised proceeds were approximately HK\$26,027,000 and HK\$31,873,000, respectively.
