5. You must be outside the United States, not be a United States Person (as defined in Regulation S under the U.S. Securities Act) and not be a legal or natural person of the PRC.
6. Unless permitted by the GEM Listing Rules, you cannot apply for any Public Offer Shares if you:
 - are an existing beneficial owner of shares in the Company and/or any of its subsidiaries;

 - have been allocated or have applied for or indicated an interest in any Placing Shares under the Placing or otherwise participated in the Placing.

B. If you are a nominee

C. Effect of completing and submitting this Application Form

Determination of Offer Price and allocation of Public Offer Shares

The Offer Price is expected to be fixed on or around Thursday, 24 May 2018. Applicants are required to pay the maximum Offer Price of HK\$0.35 for each Public Offer Share together with 1% brokerage, 0.0027% SFC transaction levy and 0.005% Stock Exchange trading fee. If the Offer Price is not agreed between the Company and the Joint Global Coordinators (for themselves and on behalf of the Underwriters) on or around Thursday, 24 May 2018, and in any event, no later than 12:00 noon on Saturday, 26 May 2018, or such later date or time as may be agreed by the Joint Global Coordinators (for themselves and on behalf of the Underwriters) and the Company, the Share Offer will not proceed.

Applications for Public Offer Shares will not be processed and no allotment of any Public Offer Shares will be made until the application lists close.
